The California Fire Code (CFC) states that manual fire alarm boxes must be located not more than 5 feet from the entrance to each exit. NFPA 72 further clarifies that manual fire alarm boxes shall be located within 5 feet (60 inches) of the exit doorway opening at each exit on each floor.

Local fire officials do not have authority to stop work unless there is an immediate threat to life safety present. Where there is an imminent threat to life safety, the local fire official should immediately contact the general contractor, the design professional in general responsible charge, the building superintendent, or the school district.

A permit for the use, storage, and handling of flammable liquids in excess of 5 gallons is required from the Fire Department. Flammable and combustible liquids must be stored in their original unopened containers. Once opened, flammable liquids must be stored in approved safety containers.

Life Safety Code & Health Care Facilities Code ...

The building code assumes one child for every 20 square feet in classrooms (kindergarten and older) and 35 square feet for younger children. That means that the Life Safety Reviewers will be assuming more children, in your facility, than you probably actually plan for. E occupancies that would have more than 50 children (as calculated by the building code) are required to have a fire alarm system.

Residential Apartment Inspections (R1/R2) are requirements set forth by the State Fire Marshal to ensure all properties that fall within the program's criteria are compliant with the general fire/life safety provisions. All multifamily residential apartment buildings in the state of California consisting of three or more units and up to 15 shall be inspected by the local fire authority.
