According to GDPR Article 39, a data protection officer's responsibilities include: Training organization employees on GDPR compliance requirements Conducting regular assessments and audits to ensure GDPR compliance Serving as the point of contact between the company and the relevant supervisory authority

The data protection officer may be a staff member of the controller or processor, or fulfil the tasks on the basis of a service contract. The controller or the processor shall publish the contact details of the data protection officer and communicate

The key principles of data protection are to safeguard and make available data under all circumstances. The term data protection is used to describe both the operational backup of data and business continuity/disaster recovery (BC/DR). Data protection strategies are evolving along two lines: data availability and data management.
